

UNITED THERAPEUTICS CORPORATION 340B Contract Pharmacy Policy Summary

United Therapeutics Corporation ("UT") is committed to the success of the 340B drug pricing program and continues to make its covered outpatient drugs available at 340B pricing to covered entities. UT's 340B contract pharmacy policy ("Policy") does not affect a covered entity's ability to order UT's covered outpatient drugs for shipment to the covered entity.

The Policy has two components: a grandfathering requirement and a claims data requirement. In order to be permitted to submit contract pharmacy orders, a covered entity must comply with <u>both</u> requirements, subject to certain exceptions as discussed below and at UT's sole discretion. UT retains sole discretion to modify or suspend the Policy at any time, in whole or in part, and to add or remove any covered entity from eligibility to place contract pharmacy orders under the Policy, pursuant to which UT provides 340B pricing through contract pharmacies on a voluntary basis.

Grandfathering Requirement

UT accepts contract pharmacy orders only if a contract pharmacy was utilized by the covered entity for a valid 340B purchase of a UT covered outpatient drug during the first three full quarters of the 2020 calendar year (i.e., January 1, 2020 through September 30, 2020). UT denies any contract pharmacy orders where the contract pharmacy does not meet this grandfathering requirement.

Claims Data Requirement

UT accepts contract pharmacy orders only if the covered entity satisfies the grandfathering requirement <u>and</u> also has agreed to provide to UT, and is providing to UT on an ongoing basis, claims data associated with all 340B contract pharmacy orders of UT's covered outpatient drugs. If a covered entity subsequently fails to provide claims data, UT will deny the covered entity's contract pharmacy orders for UT covered outpatient drugs that were dispensed after the commencement of such failure.

Limited Exception to Grandfathering Requirement

If a covered entity does not have its own on-site pharmacy (as defined below), UT, at its sole discretion, provides the covered entity with the opportunity to designate an approved, single qualified contract pharmacy for which UT will accept 340B orders. To apply for this exception, a covered entity may contact UT at 340B@unither.com. A covered entity that has been granted an exception to the grandfathering requirement also must comply with all other aspects of the Policy.

For purposes of the Policy, an "on-site pharmacy" is a pharmacy with the same address listed in the 340B Office of Pharmacy Affairs Information System (OPAIS) as the covered entity.

UT, at its sole discretion, may, at any time, modify this exception to the Policy and revoke previously granted exceptions.
